# **Philippines: Future Defence Budget and Deliveries**



According to the Philippine Defense Reform Program the goal of the country's authorities is to "create an army capable of responding to current and emerging threats that will usher in a secure, stable and peaceful environment conducive to economic growth and national development". In line with this the Department of National Defence announced that 14 big-ticket defense items, worth

Ph Pesos 6.2 billion (106 million Euros), will be completed before the end of 2014. Ten additional projects worth another Ph Pesos 17.3 billion (296 million Euros) are expected to be delivered in 2015. The major equipment to be delivered in 2015 include armored vehicle s for the PA, attack helicopters, combat utility helicopters, light lift and medium lift aircrafts for the PAF, and naval helicopters for the Philippine Navy (PN).

Defence Secretary Voltaire T. Gazmin said regarding the upcoming deliveries that: "We are getting closer to our desired state in terms of capability and readiness with our recent acquisitions, and those we are expecting to be delivered in the next few months".

The deliveries to be concluded within 2014 include the following: *assault rifles* for the Philippine Army (PA) and Philippine Marines, *UH-1H helicopters* for the Philippine Air Force (PAF), *close combat optics*, and *Explosive Ordnance Disposal (EOD) equipment*.

The revised modernization program for 2013-2017 has a budget of Ph Pesos 85.3 billion (1.45 billion Euros) which will be spread out over a five-year period. From 2013-2017, Ph Pesos 8.6 billion (147 million Euros) will be allocated to the Army, PhP 43.3 billion (740 million Euros) to the Air Force, Ph Pesos 28.2 billion (482 million) to the Navy and Ph Pesos 5.2 billion (88 million Euros) to the AFP General headquarters.

# Philippines: Past Defence Procurements



The Philippines is an archipelago of 7,107 islands with a total land area including inland bodies of water, of approximately 300,000 square kilometres (116,000 square miles).

The 36,289 kilometres (22,549 miles) of coastline makes Philippines the country with the 5th longest coastline in the world. Therefore it is normal that its defence authorities focus on procuring equipment that will help patrolling this vast coastline. It is indicative that during 2008-2013, the vast majority of funds allocated to procurement of new equipment were spent on procuring ships. Aircraft and sensors followed.

The Philippine armed forces have to procure the biggest part of their armament from foreign countries, as the national defence industry is rather underdeveloped. USA is currently the main provider of arms, receiving the largest share of the Philippine defence spending. Apart from USA, important countries that export arms to Philippines are Poland, Italy, Germany, Turkey and South Korea. As it is clearly illustrated, arm imports are rather diversified in its geographical structure as the supplying countries represent three (3) different continents, Europe (Italy, Turkey, Poland and Germany) North America (USA) and Asia (South Korea).

Among the procurements Philippines concluded during the last years is that of 4 AN/TPS-79 MMSR air search radars. Additionally the country procured 8 W-3 Sokol helicopters for a Ph Pesos 2.8 b (\$64 m) deal. Deliveries were concluded within 2013.

## Ryanair, Aegean state interest in buying Cyprus Airways



Ireland's Ryanair and Greece's Aegean Airlines are among more than 15 applicants who have made a non-binding expression of interest to buy loss-making Cypriot flag-carrier Cyprus Airways, officials said Thursday.

"The interest has surpassed our expectations but we need to point out that, at the present stage, we are simply recording that interest, so it doesn't mean that the interest will be followed up by a bid," Communications Minister Marios Demetriades told state radio Thursday.

"Aegean and Ryanair have announced their interest and there are other smaller airlines which have expressed their interest as well, but most interested parties are not airlines," he said.

He said the applicants will be evaluated at a later stage and will be called to submit binding offers by the autumn.

Reportedly, other firms who expressed an interest in buying Cyprus Airways assets include Israel-based Arkia, Romania's no-frills Blue Air, Lebanon's Middle East Airlines, as well as Spanish Group Arevenca in collaboration with Fly Aruba.

The Cypriot government, which owns 93 percent of Cyprus Airways, set the deadline for non-binding expressions of interest in shares or assets at midnight (2100 GMT) Wednesday.

The national carrier has been selling assets to keep flying, including three time slots at London's Heathrow airport.

Cyprus Airways is struggling to survive against intense competition on its most popular routes to Greece and London.

It has undergone several cost-cutting plans - axing staff, scrapping routes and downsizing its fleet -- but failed to stem losses.

It is also under investigation by the European Commission to see if it violated state aid rules in a 31 million euro share capital increase and a 73 million euro bailout from the state in the past two years.

The airline posted a net loss of 55.8 million euros for 2012, more than double the net loss of 23.88 million the previous year. Operating losses almost doubled to 49.7 million euros from 25.5 million.

# Canadian aviation giant Bombardier to cut 1,800 jobs

Canada's Bombardier will cut 1,800 jobs, the troubled aviation giant announced Wednesday in a major reorganization.

"This marks another step in Bombardier's evolution," said Pierre Beaudoin, the company's president and chief executive officer, who said the overhaul, to be completed by January 1 of next year, would reduce costs and overhead.

A spokeswoman for the Montreal-based company, Isabelle Rondeau, confirmed for AFP the size of the cuts.

Beaudoin said in his press release that the reorganization -- in particular of the company's Aerospace branch -- "will enable us to be more agile and flexible in addressing customer needs, while increasing our focus on growth areas."

Among other recent woes, Bombardier had less than anticipated demand for its CSeries medium-range planes, which for a time were plagued by costly engine problems.

Company officials announced that as part of the overhaul, one of its senior officials, Aerospace President and Chief Operating Officer Guy Hachey, is stepping down.

"Guy led Bombardier Aerospace during an important period in its history. I wish to thank him for his contributions over the past six years," Beaudoin said.

Bombardier, one of the world's largest aircraft manufacturers, is the only company to build both planes and trains.

In the fiscal year ended December 31, 2013, the company had revenues of some \$18.2 billion.

## South Africa sets 5 years to stem military decline

Continental military power South Africa committed Wednesday to save its armed forces from meltdown within five years, amid budget constraints and increasing involvement in peacekeeping missions around Africa.

A review earlier this year found the South African Defence Force (SANDF) was in a "critical state of decline" after two decades of underfunding.

"We do not have a choice, but to respond with urgency to put plans to arrest the decline within the current five years, starting immediately during this financial year," said Defence Minister Nosiviwe Mapisa-Nqakula on Wednesday.

"Although the SANDF is still able to maintain operational presence, if we do not start now, the decline will get worse," she told parliament in her budget speech.

The ministry projects a \$4 billion (3 billion euro) budget for the year, or 1.3 percent of the 2013 GDP -- far below the 2.0 percent of GDP the minister said in April would be necessary to fix the military.

"Our mandate in the next five years is to act fast to restore the minimum capabilities required to safeguard South Africa, protect its maritime resources and trade routes, conduct peace missions and humanitarian interventions," said Mapisa-Nqakula.

South Africa's once feared and respected defence force has been hit by budget cuts and much of its equipment is no longer fit for purpose. The 100,000-strong force is also bleeding skilled personnel.

As one of Africa's military powerhouses, South Africa has deployed troops to peacekeeping operations in the Democratic Republic of Congo and Sudan's Darfur.

It previously sent troops to Burundi, Lesotho and the Central African Republic. Its navy has also recently begun patrolling the coast of neighbouring Mozambique to ward off pirates.

#### EU says Ryanair must repay 9.6 mn euros in illegal state aid

The European Commission said on Wednesday that low-fare airline Ryanair must repay about 9.6 million euros in illegal state aid it received for its operations in several French regional airports.

The Commission, the European Union's executive arm, said Ryanair would have to repay 868,000 euros (\$1.16 billion) related to rebates and marketing arrangements negotiated at Angouleme airport in central France.

Ryanair had enjoyed "an undue advantage" and should repay the money so as to "remove the distortion of competition," the Commission said in a statement.

Similar findings at Pau Pyrenees airport required a repayment of 2.4 million euros with 6.4 million euros repayable at Nimes airport, both in southern France, it said.

The Commission said it was continuing an investigation into Austria's Klagenfurt airport where airport service and market agreements "appeared to be excessively favourable to Ryanair and therefore could involve incompatible state aid."

Probes into three German regional airports -- Dortmund, Leipzig/Halle and Niederrhein-Weeze, where Ryanair is the largest client -- found no problems with state-aid payments, it added.

In response, Ryanair said it welcomed the Commission's rulings on the three German airports but would appeal against the other findings.

"All of Ryanair's airport arrangements comply with EU state aid rules and Ryanair has therefore instructed its lawyers to appeal these rulings to the extent they erroneously allege otherwise," it said in a statement.

The company, which pioneered low-cost, no-frills air travel in Europe, said it currently ran four routes out of Nimes but had ceased operations at Pay Pyrenees in 2011 and at Angouleme in 2009.

#### Naval ships from US, India and Japan to start war games

The United States, India and Japan are set to kick off week-long war games in the Pacific, beefing up naval ties as they warily eye an increasingly assertive China and its military buildup.

Warships from the three countries are to begin the joint exercises on Friday, after an official opening ceremony at the Sasebo Naval Base in southern Japan on Thursday.

Known as the Malabar Exercise, the annual event usually involves India and the US, but Japan's Maritime Self-Defence Force (MSDF) will take part this year, the third time since 2007.

The exercises off Japan's southern coast come on the back of rising regional tensions as Delhi and Tokyo remain embroiled in territorial spats with Beijing.

China is also at loggerheads with some Southeast Asian nations over its claim to large swathes of the South China Sea.

Washington has been increasingly turning its focus to Asia as it looks to counter Beijing's growing influence and a military buildup that has unnerved some of its regional neighbours.

"India, Japan and the United States have a shared strategic interest," said international relations expert Takehiko Yamamoto, professor emeritus at Tokyo's Waseda University.

"The aim of this naval exercise is for (the three countries) to manage a vast sea area stretching from the western Pacific to the Indian Ocean.

"They need to make sure the lines of communication stay robust -- this exercise has China in mind," he added.

India is nervous about the so-called "string of pearls", the concept of a network of ports around the Indian Ocean to which China's navy would have access, Yamamoto said.

"For India, this is a great threat," he said.

- Growing ties -

The manoeuvres also reflect growing ties between India and Japan, on both the military and economic fronts, with Japanese Prime Minister making an official visit to Delhi in January -when the two nations agreed to "further strengthen" their defence cooperation and conduct regular naval exercises.

The July 25-30 exercises will include three Indian ships, a frigate, a destroyer and a supply ship, along with 700-800 personnel, Indian navy spokesman DK Sharma told AFP.

Sharma said the exercises would include anti-piracy, anti-terrorism, humanitarian assistance and helicopter drills.

"We just concluded... our naval drills with Russia, and since we have already travelled thousands of miles to that side, it's only natural that Japan will participate in the Malabar Exercise," he said.

The US Seventh Fleet, which covers the western Pacific and Indian Ocean, will take part in the war games while Japan is dispatching two escort ships, one US-2 search-and-rescue amphibious plane and one P3C patrol plane, said an MSDF spokesman.

He said several hundred Japanese personnel would take part.

"The purpose of Japan's participation is to improve the strategic capabilities of the MSDF and to strengthen the cooperation among the three militaries," he added.

China has lashed out at Abe after his cabinet formally endorsed a reinterpretation of Japan's pacifist constitution banning the use of armed force except in very narrowly-defined circumstances.

Beijing argued that it could open the door to remilitarisation of a country it considers insufficiently penitent for its actions in World War II.
