

# **BUSINESS CHALLENGE**

In most industrial sectors (such as chemical, automotive, metallurgical, or oil & gas), large construction projects involve the purchase of a vast number of items supplied by many different manufacturers. Quality and safety are key for these projects. So it is of vital importance to check the quality of every single item, no matter how small. These items range from raw material to finished products. As some indication of the diversity of items concerned, they can include pipes and tubes, equipment ranging from valves and faucets to boilers and motors, engines for anything from lifting equipment to elevators, electrical and electronic devices.

Any purchase carries embedded risk. If a part is faulty, but the fault is not detected, the risk of something going wrong becomes embedded within the new asset.

#### What is Shop Inspection?

Shop Inspection involves inspecting items at their place of manufacture before delivery. This is the most convenient and cost-effective way to determine whether a product, service, process, piece of equipment or installation complies with expressed needs, customer expectations, applicable regulations or other specific requirements.

Shop inspection can include design review, review of material certificates, visual inspection, various Non Destructive Testing (NDT), attendance, supervision or performance of mechanical or functional tests.

Bureau Veritas provides shop inspection services as a third party [Third Party Inspection, or TPI] and second party inspection worldwide.

TPI can be statutory (like European Directives or ASME) and carried out within the corresponding regulatory frame.

Where equipment is destined for use within Europe, Bureau Veritas can act as a notified body, performing conformity assessment on products often subject to a long list of directives and regulations.

Shop inspection services are also offered for equipment that does not have to meet mandatory requirements. Conformity can be assessed in line with any specified standards. These may be national/international standards such as the American, ASME, API codes or any other national codes such as those applicable to Australia, New Zealand, India, etc.

TPI can also be voluntary, and carried out completely independent of the parties involved (for example, in the case of ISO/IEC 17020, formerly EN45004). Scope is specified by the client, and the inspection services are then carried out at the manufacturer's workshop.

Bureau Veritas inspectors are experienced and qualified. Their individual qualifications have been earned both within Bureau Veritas (levels and fields of competence) and externally. We select inspectors to match the needs of a specific inspection.

# FAQ

# What can Bureau Veritas do that my Quality Department people could not, to inspect our purchases?

If your quality inspectors are based in one place, or a limited number of places, the cost would be prohibitive. You would need to send them to every country where pieces of equipment for your project are made.

If you choose to inspect materials and equipment parts on arrival, there are many significant risks: late assessment (if equipment is defective, there will be delays for new supply); lack of costly measuring equipment normally available at the manufacturer's workshop; inability to check items which have become hidden when the piece of equipment is assembled.

Expediting enhances the performance and successful execution of purchase contracts, covering an unlimited scope of materials and services. It improves communication, assists in the avoidance of vendor originated material, and production delays, and serves as one of the best quality assurance methods of keeping construction projects on schedule and within costs. Bureau Veritas' prime objective is to have the delivery occur at the due date and in compliance with our Client's specifications.

Bureau Veritas' Expeditors visit manufacturing plants to ascertain and confirm the pre-manufacturing, manufacturing and post-manufacturing activities through interviews and visual examination. Our Expeditors evaluate the actual progress against the scheduled manufacturing progress, which is provided by the vendor at the manufacturing plant. They utilize their experience to determine when tasks must be escalated and offer solutions on how to maintain the scheduled delivery.

Our Expeditor visits are generally made to coincide with the milestone activities to assure completion is in line with the production plan. Bureau Veritas' Expeditor provides information and is as transparent as possible to our clients, providing real-time fabrication data which includes the following:

#### Verify that purchasing specifications have been properly understood and applied on-site.

- Collecting and reporting directions for visits to the supplier at a defined frequency (from client supplied documents).
- Assuring the supplier's commitment to maintaining the proper level of effort to meet the established production program targets and schedule.
- Verifying all required steps in the work process / schedule are completed prior to items shipped.

#### Identify difficulties or issues which may affect the time delivery of the client's products.

- Assuring that any delivery slippage or production performance related problems are raised at the appropriate level in the suppliers' works.
- Anticipating delivery problems and reporting accordingly, proposing actions required to prevent problem occurring.
- Reporting remedial actions required to recover production program slippage.

#### Facilitate communication between client and suppliers.

- Verifying and communicating the achievement of progress claimed by the supplier.
- Advising of any serious problems or delays anticipated or encountered during visits.
- Verifying that expediting reports are written for each purchase order or sub-order on each supplier that are visited and forwarded to the client for verification and approval prior to shipment of any items.

# What does the Phase I Environmental Site Assessment cover?

Phase I ESA is a report prepared for real estate holdings which identifies specific environmental contamination liabilities.

The main aspects include: potential soil contamination, underground water quality, surface water quality, definition of chemical residues within building structures, identification of building materials containing asbestos, inventory of toxic substances stored or used on site, assessment of mould and mildew and evaluation of other indoor air quality parameters.

It is necessary to make all demands of certification against MSC "chain of custody" to an accredited certification body in order to show your capacity to manage in a rigorous way the traceability of fishing products coming from MSC certified fisheries.
