NIDV-Symposium: International Cooperation



Registration open now!

The current geopolitical situation requires that the Netherlands must increasingly collaborate internationally with regard to security issues. International parties include NATO and the EU, as well as a wide range of binational and multinational partnerships. Dutch industry needs to align itself with these partnerships, especially in the areas of research, development and equipment production and also with regard to staff exchanges and retention.

On the one hand, much funding is made available to progress towards closer collaboration within Europe in the area of Defence and Security. The European Defence Fund is making more than €13 billion available in the coming years. For military mobility aimed at simplifying the movement of military equipment within Europe, an additional €6.5 billion in funding is being made available, while close to €5 billion has been allocated for civil security in Europe. This funding is in addition to the funding made available by the Member States directly for European-based projects. The NIDV wants to keep its members updated on these developments as much as possible so companies can decide for themselves whether or not to take part in European initiatives.

On the other hand, countries want to protect their economies, support their own industry and remain sovereign states. A level playing field in Europe will be difficult to establish in the decades to come. The competitive position of Dutch defence companies is therefore under considerable pressure. Competing for European Defence projects is a difficult challenge for both major Dutch corporations and small- and medium-sized businesses. Nonetheless, international collaboration is essential in a time of geopolitical threats.

International collaboration, the theme of the NIDV Symposium 2018 to be held on 15 November at the Ahoy Rotterdam, requires efforts of the Netherlands and its partner countries. During the NIDV Symposium, moderator Angelien Eijsink will be introducing two interesting speakers and high calibre visitors throughout the morning. Presentations, breakout sessions and representatives of international organisations and companies will make clear that Dutch industry, knowledge institutes and government are ready and willing to partner up. After all, there is greater strength in numbers - in Europe and the rest of the world.



During the Symposium, the European Military Press Association (EMPA) will be our guest concerning their yearly conference. 20 to 50 journalists from all over Europe will visit the exhibition to get inspired by new technologies and inform themselves about the current situation of international cooperation.

The vision of the Invictus Games 2020 The Hague can be characterised by a few basic principles. The Games will be mounted in a lean and efficient manner to focus on delivering the best possible competitor experience. The Invictus Games will use existing, sustainable venues and accommodations that are easily accessible and situated in a compact area.

The Invictus Games 2020 will be held in The Hague and Rotterdam, which are cities with an intense and deep international orientation. Rotterdam is the main port of Europe, and The Hague is the international city of Peace and Justice, and both have an open culture with a wide variety of international components. The city-bond between The Hague and Rotterdam is closely linked to freedom and sacrifice. Both cities suffered heavily during WWII and rose shoulder to shoulder from the ashes. In 2020, 75 years after the liberation, the Invictus Games will link the past to the present. The Hague - Rotterdam metropole is a fitting example of a collaborative ecosystem for economic, governmental and sports development. Both cities have high-density areas with populations drawn to big events and boast state-of-the-art facilities for sports, culture and entertainment.

The Invictus Games 2020 will be a self-supporting event. To avoid the extensive use of governmental financial support, the Games organisation will be made possible by founders and private funding.



However, the government is supporting the Games with a subsidy but the goal is that the use of public funds should be minimised.

Above all the Invictus Games will be superb! The Games serves the purpose to honour the soldiers and their loved-ones. It is an event that has a local and global effect by increasing the respect for those who serve(d) and creating a mind-set that freedom does not come for free.

Masterclass Naval

The Masterclass Naval will take place this year on 24 October and 31 October.





Companies delivering to the Ministry of Defence and in particular the Navy do not always have a complete picture of the organisation and the tendering process. It is often considered a 'black box'. The aim of the masterclass is to give the participants a (better) picture of the functioning of the Royal Navy at all levels.

Characteristic of this training is the interactive character linking the government, companies and knowledge institutes. This is done through interactive presentations and dialogues with both officers on staff and operational level and the personnel on the "work floor" at locations The Hague and Den Helder

This master class takes place in 2 days. The information module on the procurement process, major new building and replacement projects and cyber security will be held at the Ministry of Defence in The Hague on 24 October. On 31 October, at the location of the Navy in Den Helder, the operational module will take place.

The corporate sector brainstorms with police



Last April the Police Academy hosted the Police Vehicle Day 2018. A supplier day based on a new concept because brainstorming together to solve problems without knowing whether it yields anything is always exciting. In the meantime the overview of results has been presented to a steering committee and a decision is expected in September.

Looking for the best solution

This was the first time that we held our suppliers' day based on this concept. We invited several suppliers in the vehicle sector to join the police during Vehicle Day to explore a number of issues and together look for concrete (and innovative) solutions.



According to strategic police advisor innovation Nick Koeman, the operational colleagues have very clear opinions on everything related to vehicles. "This may involve concrete adjustments in or around the vehicles, or could be about more conceptual issues. The heart of many colleagues will skip a beat when it comes to vehicles. VK&I conducted a survey among our operational colleagues that brought up a lot of important points. We wanted to sit down with our suppliers and think outside of the box to find solutions."

Both parties needed to sit down and feel each other out. "We usually think of the most obvious solutions, but that doesn't necessarily mean it's the best solution. By inviting our suppliers to think in terms of their expertise, we hope to find less obvious solutions that you don't think 1-2-3," explains Math Steevens (PDM service manager, Air, Road and Water transportation).

Meet, greet and eat with the suppliers

Around forty suppliers attended the Vehicle Day event. After a presentation by Pim Mittenburg (deputy chief of police unit East) about the operational management of the police, there was insight into the area of air, road and water transportation. Then it was time for the suppliers, with or without product concepts, to visit the various booths and engage with PDM and operational colleagues. Issues discussed included the use of multi-functional buses, forced and controlled vehicle stops and the use of a security screen in vehicles.

Evaluating the information

Operational staff members and staff from the police service centre were very interested in hearing the suggestions and solutions of the seven different themes related to police vehicles.

The content of these conversations yielded an overview of tangible results. This overview was discussed internally and will now be presented for evaluation to the steering committee that includes police vehicles. They expect a decision in September (when staff returns from holidays).

Cyber Symposium

On 12 September, the NIDV, together with a number of government and business partners, is organising the 3rd NIDV Cyber Symposium.

The focus is on the business community (including NIDV participants) as well as on military and civil security partners.

The programme of this symposium is dedicated to the NIDV Cyber Resistance Plan DVI (Defence & Security-related Industry). This plan aims, among other things, to create better cooperation between the Defence & Security-related industry, NL Cybersecurity companies and various governments to bring the level of cyber resilience of the Dutch DVI to an ABDO 2017 (General Security Requirements for Defence Orders) level.

Regarding the Cyber Resistance Plan, we start with the approx. 700 companies that have to comply contractually with ABDO 2017 and will negotiate with the government to make a voluntary ABDO 2017 certification possible. In addition, we are working on a register with NL Cybersecurity companies that (can) meet ABDO 2017, and we investigate the possibilities for a NL Trusted ABDO Cloud.
